The Phase-I Preliminary Exam and Phase II Main Exam. for the post of UDC was held on 14.07.2019 and 01.09.2019 respectively. The Phase - III Computer Skill Test for the Recruitment to the post of UDC was held on 20<sup>th</sup> October, 2019.
